## APPEALING FOR ASSISTANCE

Hornsby Detectives are appealing for information following an incident at Hornsby Mall last month.

Just before 1pm on Saturday 25 January 2020 a group of bike riders were riding in the area near the George Street footbridge.

At the time there were several pedestrians in the area.

Police have been told there was an interaction between one of the pedestrians and an 11-year-old rider.

The boy has fallen from his bike and suffered a fractured arm.

### **6 February, from Crime Stoppers NSW**

Did you know that it is a crime if you make, send out, or have an “offensive” image of someone under the age of 18 (including of yourself) who is:

- 📷 Showing their private parts, which includes a person's genital area, anal area or female breasts
- 📷 Posing or acting in a sexual way; in the presence of another person involved in sexual activity or pose, or
- 📷 Involved in a sexual activity.

The law calls these images CHILD ABUSE MATERIAL, or more commonly – Child pornography.

If you are found guilty of a sexting crime, you may be placed on the Australian National Child Offender Register.

It is important to protect yourself by deleting any pictures you are unsure or uncomfortable about straightaway. It is really difficult to keep images private and once they are shared, you will never be able to delete those pictures forever. Never share it online or through SMS, and only show it to a trusted adult.

If you know or suspect someone is producing, downloading or sharing child sexual abuse material you can make a confidential report to Crime Stoppers on 1800 333 000 or visit [site here](#).

The quote was \$6,500.


The man is described as being in his early 30s, Islander appearance with large build, a sleeve tattoo and wearing black shorts, a black hat and the orange high-viz top.

It's highly likely they'll take a lot of your money, do little or nothing in return and disappear.

### **5 February, from Kuring Gai Police Area Command - Prayers have been answered!**



5 DAYS IN THE NSW SOUTH COAST FIRE REGION in a nutshell ~ (Kuring-Gai Police Area Command).

A huge thank you to the SES, VRA, the Army and in particular the NSW RFS for the tireless work you are all doing.

A colleague and I had the privilege of spending the last 5 days working down south with our colleagues from other Police Area Commands and the organisations noted above. We drove to the NSW South Coast and had the opportunity while there to speak with those who have been both directly and indirectly affected by

the fires over the last few weeks and months.

We worked closely with the SES, RFS, VRA and the Army. It was not only wonderful, but an eye opener, to see all the agencies working so closely and effectively together.

When speaking with teens, couples, families and their kids, senior folk, shop owners and staff of business and shops, and giving little toys to kids, we found they all had a story they were happy to share.

We heard stories of heartfelt sadness and upbeat stories, were told of the constant feeling of being "on edge" for months. Some have been evacuated five and six times from their homes. This same gentleman who has a mate who lost his home said, "well you just have to be grateful eh!"

We were directly involved in warning the residents of the pending danger with fires in the Merimbula, Pambula and Bega Valley areas, looking for potential looters and backing up our police colleagues in the South Coast and Bega Valley areas.

We patrolled from Bega right to the Victorian border and back again; drove through the devastation around Batemans Bay and Mogo on our way down and saw the black ash sludge on the waterfront in Merimbula.

When patrolling through the Cobargo area we came across a vehicle parked near a property which used to have a home on it. Hoping it wasn't looters we approached the three brick chimneys still standing tall but with the corrugated iron roof now twisted and scorched, lying on the ground covering the remnants of a much loved home. We spoke to the family sitting on camping chairs looking at a laptop placed on a card table under the shade of a tree directly beside their raised home. They were taking stock of their situation and yet had a positive outlook on their temporarily halted lives.

We saw the burnt fields blackened by the fires that had raced uncontrollably over the land, enveloping trees along with homes; no discernible pattern, just random destruction.

We saw the fires glowing in the night and the smoking firefront on the mountainside above Candelo.

The locals are strong and positive but it will take a long time for them to get their lives back to some sort of normality.

The fires are still threatening in this area and other areas around our country.

We can only hope and pray for heavy rains to come soon. Both my colleague and I truly appreciated the opportunity given to us to do a little bit for the South Coast Region.

Keeping young people safe online is very important to us and to the NSW Police Force. Safer Internet Day is a chance for us to raise awareness about online safety.



### **From Hornsby Advocate, 5 February [\[Link here\]](#)**

A HORNSBY man allegedly spent Australia Day taking several videos up women's skirts at Woolworths Town Hall.

The 37-year-old man was arrested on Sunday and taken to Day St Police Station where he was charged with film person's private parts without consent.

It came to officers' attention while they were patrolling the Sydney CBD area about 3.20pm when a confrontation unfolded between the man and security staff at the supermarket on Park and George streets.

Police were told a shopper had witnessed the man "upskirting" a woman in the store and reported the incident to security.

As a result the officers were able to search the accused's phone and it's alleged seven videos had been discovered involving the women who were shopping in the supermarket on the day.

The man, from Hornsby, has been granted strict conditional bail and he is set to appear at Downing Centre Local Court on Wednesday, March 3.

### **ST IVES**

Police are searching for five males involved in an altercation with a teenage boy who was whacked with a tree branch, stabbed and robbed on Australia Day eve. The incident happened about 6pm on Saturday at Barra Brui Oval, Burraneer Ave. According to police reports, a group of five males suddenly set upon the 17-year-

old who was hit with a big tree branch, stabbed twice in the shoulder and a metal object was thrown at him. The group of male offenders stole his phone before fleeing the scene. The 17-year-old victim was sent to Hornsby Hospital for treatment with reports he is recovering. Officers from Ku-ring-gai Police Area Command are investigating the incident and searching for the five males involved. The males have been described as caucasian with one in his early to mid teens and the others in their mid to late teens. Anyone with information about this incident is urged to contact Crime Stoppers

## **ASQUITH**

Police are investigating two robberies which happened at different addresses on Heath St between 5pm on November 22 and 10am on January 22. It was reported two water meters worth \$300 each had been taken from the ground in the front yards of vacant blocks.

## **BEROWRA**

Berowra Public School was the target of graffiti vandalism between 5.30pm on January 24 and 6am on January 28. An unknown person or persons caused malicious damage to a wall on one of the toilet blocks and on the wall of the canteen. Illegal tags and pictures were seen in yellow spray paint with no tools left at the scene. It comes after another incident between January 2 and January 6 where an unknown person or persons damaged signage and the footpath adjacent to the administration building by producing graffiti with chalk and black text. It's been estimated the cost of damage is \$400. During this same incident offenders pulled down external electrical conduit and exposing wires attached to the hall walkway. The estimated cost of the more recent damage is \$200.

## **HORNSBY**

On January 27 there was a small grass fire reported at 3pm on Quarry Rd. It's believed it started about 50 metres past the locked gate leading into the quarry. Firefighters extinguished the small fire within minutes. Investigators do not believe the blaze was suspicious but rather accidental. Police canvassed the scene and located an array items such as a sleeping bag, burnt clothing and a jerry can. Police seized a jerry can as evidence. Investigations are ongoing.

## **WAHROONGA**

A man was arrested and taken to Hornsby police station after he was stopped for a random breath test about 4am on January 25. The man was on the Pacific

Highway when he was pulled over. He returned a positive reading and when he was tested again at Hornsby Police Station a reading of 0.061 was returned, which was classified as low-range. As a result he was issued with an infringement number and his license was suspended for three months.

## **WEST PYMBLE**

Police were conducting random breath tests when they attempted to stop a male driver who didn't pull over while travelling in a northerly direction on Ryde Rd. The incident happened at 12.45am on January 24. Officers followed him and found him on Andrews Rd in West Pymble, 1.5km from the RBT site. The driver was tested and returned a positive result. He was later arrested and taken to Gordon Police Station where he was tested again. He returned a midrange reading of 0.084. As a result he was issued a licence suspension notice.

**10 February, From the ACCC Scamwatch radar alert [Edited]:** Romance scammers move to new apps, costing Aussies more than \$28.6 million

Scammers are using new online platforms to take advantage of their victims, with dating and romance scams making up one fifth of losses across all scams reported to Scamwatch in 2019.

Australians reported almost 4,000 dating and romance scams in 2019, with losses of more than \$28.6 million, and these numbers will be just the tip of the iceberg. Around 37.5 per cent of reports resulted in a loss, with an average loss of more than \$19,000.

Beyond traditional online dating websites, the highest losses were from romance scams originating on Instagram and Facebook. Conventional dating platforms, such as Tinder or [Match.com](https://www.match.com), also had high losses.

A new trend emerging in 2019 was scammers increasingly turning to apps like Google Hangouts, or online games such as Words with Friends and Scrabble to con their victims.

"We've seen an increase in reports from people who did not originally seek an online relationship but have been caught up in a dating and romance scam," ACCC Deputy Chair Delia Rickard said.

### **Facts and figures:**

31.4 per cent of dating and romance scams occurred via social media and online forums.

The highest losses (over 33 per cent or \$9.1 million) occurred via social media. Instagram was the most common social media website totalling 8.8 per cent of dating and romance scam reports.

Facebook was the social media website that incurred the highest losses totalling 7.3 per cent of all losses.

People aged 45–64 were most affected with 1470 reports and over \$18 million in

losses. This represents 63 per cent of total losses to dating and romance scams. Women reported 54.9 per cent (2165 reports) of all dating and romance scam reports, with the remainder 43.3 per cent (1707 reports) made by men, and 1.8 per cent (74 reports) did not specify gender.

Women reported the highest total losses of \$21.5 million (75.3 per cent of all losses). Men reported \$7 million or 24.6 per cent of the total losses.

The majority of losses occurred via bank transfer, totalling 33.8 per cent or almost \$9.7 million. This was followed by 'other payment' method such as iTunes, Steam and Google Play gift cards, which totalled \$8.8 million or 30.8 per cent of all losses. ### Dating & romance

Scammers take advantage of people looking for romantic partners, often via dating websites, apps or social media by pretending to be prospective companions. They play on emotional triggers to get you to provide money, gifts or personal details.

### 8 February, from Choice

Insurance companies are failing Australians with confusing fire cover.

**When is a fire not a fire?**

Insurance companies can define 'fire' however they like. These are the worst examples CHOICE experts found:

- AAMI** ← AAMI, APIA and GIO all have confusing exclusions. If heat from a passing bushfire affects parts of your building or contents but doesn't ignite a burning building within 10 metres you won't be covered.
- Apia** ←
- GIO** ←
- coles** ← Flames have to be present for your cover to kick in.
- youi** ← Youi doesn't cover scorching, melting or smouldering unless there are flames. Cover is confusingly different for buildings and contents.
- Budget Direct** ← Budget Direct, Virgin Money and ING won't cover you for "smoke or soot when no damage from fire has occurred".
- Virgin Money** ←
- ING** ←
- QBE** ← QBE "won't cover damage caused by charring, melting or scorching as a result of fire without the presence of flames".

**CHOICE**

Right now, there is no standard definition of 'fire' across insurance policies. This means insurance companies are free to define 'fire' however they like – and you may be paying for cover that has loopholes when it comes to natural disasters.

CHOICE experts have revealed the worst 'fire' definitions and exclusions hidden in insurance contracts. Sign the petition to close this shonky loophole now.

## **8 February, from 7news.com.au: Elderly Adelaide woman's Telstra scam warning after losing \$11,000**



An Adelaide pensioner has been left distraught after falling prey to a scammer, saying she "feels like a fool".

The fraudster pretended to be a Telstra technician and hacked into her computer and mobile phone, gaining access to thousands of dollars.

Glynis Randall, 74, received a phone call on Wednesday afternoon from a man claiming to be a Telstra technician, calling to fix a virus on her computer.

Randall says the man told her personal details including her address and how much her monthly fee was with Telstra, leading her to believe his legitimacy.

“Then he said, ‘I’d like you to download an app’,” she said.

She did.

## **7 February, from NSW Police Force**

A man will face court today after Criminal Groups Squad detectives seized more than 13kg of MDMA as part of their investigation into drug supply across Sydney.

In 2019, detectives from the Criminal Group Squad established Strike Force Medgun to investigate the activities of a criminal syndicate believed to be involved in the supply of prohibited drugs.

As part of their investigations, strike force detectives executed search warrants at St Clair, Wentworth Point, and Zetland from 9.45am yesterday (Thursday 6 February 2020).

During the searches, police seized 13.2kg of MDMA in various forms, 240g of cocaine, items consistent with drug supply, about \$6000 cash, a Ford Ranger Wildtrak, a Mercedes C63 AMG, and various items suspected of being the proceeds of crime.

In total, the prohibited drugs have an estimated potential street value of more than \$650,000.

Following further inquiries, a 29-year-old man was arrested by investigators on the Pacific Highway, Pymble, about 3.30pm.

He was taken to Hornsby Police Station and charged with drug supply (large commercial quantity), drug supply (commercial quantity) and knowingly deal with proceeds of crime.

The Zetland man has been refused bail to appear at Hornsby Local Court today (Friday 7 February 2020).

A 33-year-old woman was arrested after being found in possession of amphetamine when she returned to the Wentworth Point property.

She was taken to Auburn Police Station and charged with possess prohibited drug. She was granted strict conditional bail and is due to appear at Burwood Local

Court on Wednesday 19 March 2020.

Investigations under Strike Force Medgun are continuing.

**6 February, from NSW Police Force**

A man has been charged following an investigation into a series of alleged thefts involving vending machines at train stations across Sydney's north-west.

Officers attached to the North/Central Sector of the Police Transport Command have been investigating multiple reports of thefts and damage caused to vending machines at train stations in West Ryde and Rhodes last year.

Following inquiries, police attended a house in Ryde and arrested a 48-year-old man just before 10am yesterday (Wednesday 5 February 2020).

He was taken to Ryde Police Station and charged with three counts of larceny and three counts of destroy or damage property.

It will be alleged in court that on Saturday 4 May 2019 and Wednesday 2 October 2019, a man allegedly broke into a vending machine at West Ryde Railway Station and stole items including earphones, adapters and sim cards.

It will be further alleged on Tuesday 18 June 2019 and Wednesday 29 October 2019 at Rhodes Railway Station, another vending machine selling electrical items

was broken in to, with cash stolen on one occasion.

The man was granted condition bail to appear before Burwood Local Court on Monday 17 February 2020.
